  - Wolniak – 205 Creamery Trail – Remodel – Action Item 2017-10-1 – The Wolniak’s presented final plans for their remodel. Changes from the previous proposal included widening the driveway and adding a hammerhead, adding a retaining wall, removing the metal material. They requested a variance for their shingle material and will need an easement through Tract F. After discussion and amendment, and upon motion made by Director DeMore and seconded by Director Pyke, it was RESOLVED that the application be, and hereby is APPROVED as presented.
  - Reynolds – 179 Hummingbird Trail – Remodel/Exterior Stairs – Action Item 2017-10-2 – The Reynolds architect presented final plans for a remodel. Changes from the previous proposal included removing the exterior stairs and adding pavers. Neighbor comments included concern about a lock off, and privacy concerns. The DRC suggested some additional landscaping to mitigate some of the privacy concerns. After discussion and amendment, and upon motion made by Director Allen and seconded by Director Leingang, it was RESOLVED that the application be, and hereby is APPROVED, pending a meeting between Tracy Erickson, the Reynolds and the neighbors to discuss landscaping.

1. Call to order – 9:55am
2. Member Input
  - Michael Cacioppo, a non-homestead member or owner, was present on behalf of Elaine Turnbull and Barbara Allen to give a presentation regarding Barbara Allens easement through Homestead property.   - Nominating Committee – Give Direction/Set Meeting Date – Informational Item 2017-10-2 - - The Board discussed the upcoming Board election, and the nominating committee's roles and responsibilities in the nomination of candidates. Director McNamara and Leingangs terms are up. The committee currently consists of Larry Agneberg and Director Allen (as the Board representative). They may have one additional member if anyone comes forward.

- Eagle River Fire Protection District – Edwards Fire Station Construction – Informational Item 2017-10-3 – Todd Goulding, ERFPD's project manager, was present to discuss updates on the project, and will continue to attend board meetings throughout the project. Changes since last month include moving the entire fire station 8 feet to the east, to avoid piping the Dodd ditch, and moving the construction fence due to that change. The district has resubmitted for a permit and plans to break ground in about two weeks. They are still anticipating the project to take 12-14 months to complete. They are still planning to put large trees behind the training facility to screen it from Homestead residents.
