### PREVIOUS MINUTES

Copies of the Minutes of the 2011 Annual Meeting of the General Membership of the Homestead Owners Association, Inc. were made available to the general membership on the website prior to the 2012 meeting. The minutes of the annual meeting held on February 21, 2011 were approved.

#### OFFICERS REPORT

Board President Bobby Ladd discussed the general state of the Association and Club, mentioning that outside memberships, tennis and personal training revenues are down due to the recession. However despite the economy the Club sees continued growth in our children's programs such as Kids Camp and After School Program. Director Ladd also noted that reserves are funded as recommended per our 2010 reserve study. Major reserve expenditures for 2011 consisted of replacing the HCC playground behind the tennis courts, remodeling the school space that is attached to the Court Club, and new HVAC system for the babysitting room. Reserve expenditures scheduled for 2012 include locker room update, replacement of the hot tub, repair elevator, update the HCC Townhome that Homestead owns, and possible expansion of the upstairs of the Club/front entry remodel.

#### TREASURERS REPORT

Director DeMore announced totals for 2010 (\$893,667) and 2011 (\$892,390) total homeowner dues collected. The Reserve and Capital Improvements fund account balance for January 1<sup>st</sup>, 2011 was \$2,234,746, and on January 1<sup>st</sup>, 2012 the total is \$2,444,036. Interest income in 2011 was \$33,559. In 2011 we did not budget for a capital contribution and had a reserve contribution of \$370,000. We also put aside the excess income of 2011 into the Capital Improvement Fund to start 2012 with \$366,543 balance. In 2011 and 2012 we put all legal expenses pertaining to the Allen Easement issue to come out of the Capital Reserve Account (which was \$64,035 on legal fees and \$6,966 was spent on the Open Space Easement). For 2012 the Board decided to leave the monthly Dues at \$90 for the fifth year in a row and was still able to meet the reserve study required funding amount. Director DeMore also reported

that over the past six years Homestead has chosen to have the financials more strictly reviewed as opposed to just compiled. Director DeMore noted that there we currently are owed \$21,701 on accounts that are 90 days past due and there are currently 4 units in foreclosure and 2 in bankruptcy. Additionally, we wrote off \$3,522.71 in Bad Debt for 3 foreclosures. Homestead has a 0 based budget for 2012.

# **ELECTION OF NEW DIRECTORS**

Two board members' terms had expired-Billy Carty and Norm Green. Candidates for the director positions were Ken Marchetti and Norm Green. No candidates were nominated from the floor. Candidates were all introduced and gave brief statements. Ken Marchetti and Norm Green were elected to the Board.

# **NEW BUSINESS**

Homestead's attorney, David Firmin, gave an update on the Allen Lawsuit and opened the floor to questions. The Board gave an update regarding the Eagle County Open Space purchase adjacent to Homestead. Toby Sprunk and John Stavney with the Eagle County Open Space gave a presentation announcing that 322 acres will be put into the conservation easement. There will be a small parking area enclosed by a split rail fence, and there will be no overnight parking allowed, no vehicle access on the trail. The intension is to eventually have the Edwards Metro District be the owner and have them maintain the open space property once all documents are finalized in mid-March.

# OWNER QUESTIONS

Owners had many questions about accounting, dues, reserve funding, the new Jacuzzi, when Board meetings are held, when the Annual Meeting is held, term limits on Board Members, and the Scudder/Webster property. The Board addressed these issues individually.

There being no additional business, the meeting was adjourned at approximately 8:30 p.m.
