**Superstars (7-9 year olds)** free racquet if you're a 1st timer in HCC program! Work towards developing dependable strokes, ball placement, and consistency.

Junior Aces (10+ year olds) Proceeding towards more advanced tactics, and the technique needed to execute those tactics. More advanced point play is introduced, but there is room for kids who are just beginning to play tennis.

**High School Prep (12+ years old)** This class is designed for players who have limited or no tennis experience and want to get involve in a new sport or refine their skills for future groups.

**High School Advanced (14 + year olds)** Players who are generally more experienced with match play. Education, exercise, and entertainment (having fun) is still the key. A sense of team spirit and good sportsmanship is developed with this group.

**Jet Program (Invite only)** Designed for competitive players who are experienced USTA tournament level players.
