Swim Team Prep is designed to help young swimmers prepare to join swim team. Swimmers must be able to complete one length of the pool without stopping. Swim Team Prep will be held on Wednesdays from 5:30-6:00pm and on Saturdays from 8:00-8:30am.

Swim Team:

Swimmers will practice and improve all four strokes, increase swimming endurance and have fun, with sufficient time for team building and games that will help to improve your swimmers confidence. Swimmers must know at least two strokes. Swim Team will be held on Wednesdays from 6:00-7:00pm and on Saturdays from 8:30-9:30am.
