### **Pet Policies Reminder**

Homestead Owners Association has recently received some comments about our neighborhood pets. These comments were mainly regarding two issues: animal control and animal waste. Homestead rules require that dogs be under "immediate control" which includes leashing them or keeping them within 10 feet of you and under voice control. Uncontrolled dogs, including dogs left outside on private property not under voice control, have created problems for other dog owners who have their own pets leashed, for people trying to ride bicycles, or for people who are uncomfortable around unleashed pets. Uncontrolled dogs have also been known to bark excessively, which violates Homesteads noise guidelines and Eagle County laws. Please be courteous to your neighbors by keeping your dog under your control. Additionally, dog waste should be cleaned up after at all times in the interest of public enjoyment of our neighborhood and public health.

Homestead Owner Association would like to suggest a reasonable balance - or at least, some balance - between the needs of a dog owner and the safety and comfort of other residents. For member safety there are no pets allowed at any time on Homestead Court Club grounds, playgrounds and soccer fields.
