## 2019 Spring League Info & Rules—NON-FIXED PARTNERS

- Dates:** April 1 - June 14
- Times:** Play will be at either 6:00pm or 7:30pm for the evening leagues and at 1:00pm or 2:30pm for the Monday daytime league (Court times are 1.5 hours)
- Price:** \$35 for members
- Rules:**
- You must be a Homestead member to join the Club leagues.
  - You may only sign up for one league as a regular, you may sub in additional leagues
  - You must sign up in your NTRP level.
  - You may only sign up for yourself for all leagues
  - You must be able to play at either 6:00pm or 7:30pm for evening leagues and at 1:00pm or 2:30pm for the daytime league.
  - You are responsible to attend every week, if you are unable to attend, you must notify Tracy in advance, so he does not schedule you that week. If you are planning on missing three weeks or more throughout the session, please sign up as a sub.
  - Non-members may sub. Non-member subs must check in at the front desk, sign a liability waiver, and pay the \$15 guest fee every time they sub.
  - Subs must play at or above their NTRP level.
  - All league play will be held on indoor courts.

## League Explanation for 2019

Email is required at sign up. All league line ups are emailed to players prior to play. Players play one set no-ad scoring (receivers choose) with each player on their court, tie breaker played a 4-all. Set is first to 5 games. If you are unsure about your NTRP level, a Homestead tennis pro will assess your NTRP level.
