## 2019 FALL JUNIOR TENNIS CLINICS TIMES & REGISTRATION FORM ON BACK

**Mighty Mites (4-6 year olds)** Emphasize hand-eye coordination, strokes, footwork, and most importantly FUN! This is an entry level 30 minute clinic, offered 1-4 days per week. Free racquet if you're a 1st timer in our program!

**Superstars (7-9 year olds)** Work towards developing dependable strokes, ball placement, and consistency. This is an entry level 60 minute clinic, offered 1-5 days per week. Free racquet if you're a 1st timer in our program!

**Junior Aces (10+ year olds)** Proceeding towards more advanced tactics, and the technique needed to execute those tactics. More advanced point play is introduced, but there is room for kids who are just beginning to play tennis. This is an entry to intermediate 60 minute clinic, offered 1-5 days per week.

**High School Prep (12+ years old)** This class is designed for players who have limited or no tennis experience and want to get involved in a new sport or refine their skills for future groups. This is an entry level 60 minute clinic, offered 1-5 days per week.

**High School Advanced (14+ year olds)** Players who are generally more experienced with match play. Education, exercise, and entertainment (having fun) is still the key. A sense of team spirit and good sportsmanship is developed with this group. This is an intermediate 60 minute clinic, offered 1-5 days per week.

**Jet Program (Invite only)** Designed for competitive players who are experienced USTA tournament level players. This 60 minute clinic is an advanced program with pro approval required, offered 1-5 days per week.

I assume all risks of all conditions. In consideration of the acceptance of this waiver, I, on behalf of myself, executors, heirs, and next of kin, hereby assume all risks of any participation in tennis programming and release and discharge from any and all claims for any damage, for death, personal injury, property damage arising from any participation in the tennis programming at the Homestead Court Club/Homeowners Association, all Homestead Employees, and other participants (the "Released Parties"). I further agree that any controversy or claim arising out of or relating to this agreement shall be settled by final and binding arbitration administered by the American Arbitration Association and judgment on the award rendered by the arbitrators, who shall have no authority to award punitive or other damages not measured by the prevailing party's actual damages, may be entered in any court having jurisdiction thereof. If I am signing this Liability Release on behalf of a minor (less than 18 years of age)(the "Child"), 1) I represent that I am the parent/legal guardian of such Child; 2) I accept responsibility and agree to indemnify the Released Party for all of the Child's medical expenses incurred in connection with the tennis programming, any claims whatsoever brought by the Child, any claims whatsoever brought by the Child, any claims brought by a third party arising in connection with the Child; and 3) I acknowledge that I am signing this Release of Liability on behalf of the Child and that the Child will be bound by all terms of this Release Liability. This Release of Liability supersedes any other agreement or representation by Released party and is governed by the Laws of the State of Colorado. 4) **Lastly, If I am not staying with the Child at all times I understand that it is my responsibility to sign the Child in and out with the Tennis Instructor.** By signing below I agree that I have read all the terms and conditions as listed above.
