Summer Tennis Dates: May 25 — August 14 (12 weeks) Registration Open Now

Summer Program Info: We are very excited to announce that we have received approval to give a limited number of small group lessons with up to four participants per lesson beginning Monday, May 25. We will begin Superstars, Junior Aces and High School groups at that time. Unfortunately our Mighty Mites groups will have to be postponed until further notice. Additionally, we are only open to current members at this time. We have new policies and procedures in place to protect your children and our staff. Please read below.

COVID Policies:

- Children may not attend if they have exhibited any symptoms of COVID-19 or have had a fever within the past 7 days. Children will be given a verbal health screening, as is required by Eagle County Health Ordinance.
- Children exhibiting any symptoms of COVID-19 will be sent home immediately.
- Children will need to be dropped in front of the Club by a parent and picked up promptly at the end of lesson time.
- We will not allow parents on court at this time.
- Children will need to wear a mask through the check in front desk area on the way in and out of the club. They will not be required to wear a mask while on court. Pros are not required to wear masks while on court.
- Lessons will be held outdoors on Court 1 & 2. In case of rain, lessons will move inside to courts 7 & 8.

• Children will be asked not to handle balls, and will be asked to maintain social distancing to the best of their ability. We will have a maximum of 2 children on either side of the court.

- Children need to bring their own water bottle and come with sunscreen on; neither will be provided by the club.
- Please have your children wash hands prior and following lesson times.

SUMMER 2020 JUNIOR TENNIS CLINICS TIMES & REGISTRATION FORM ON BACK

Superstars (7-9 year olds) Work towards developing dependable strokes, ball placement, and consistency. This is an entry level 60 minute clinic, offered 1-5 days per week.


Junior Aces (10+ year olds) Proceeding towards more advanced tactics, and the technique needed to execute those tactics. More advanced point play is introduced, but there is room for kids who are just beginning to play tennis. This is an entry to intermediate 60 minute clinic, offered 1-5 days per week.

High School Prep (12+ years old) This class is designed for players who have limited or no tennis experience and want to get involved in a new sport or refine their skills for future groups. This is an entry level 60 minute clinic, offered 1-5 days per week.

High School Advanced (14 + year olds) Players who are generally more experienced with match play. Education, exercise, and entertainment (having fun) is still the key. A sense of team spirit and good sportsmanship is developed with this group. This is an intermediate 90 minute clinic, offered 1 -5 days per week.

Jet Program (Invite only) Designed for competitive players who are experienced USTA tournament level players. This 90 minute clinic is an advanced program with pro approval required, offered 1-5 days per week.
