

## **HCC Summer 2021 Junior Tennis**

Summer Tennis Dates: June 7 — August 13 (10 weeks) COVID Policies:

- Children may not attend if they have exhibited any symptoms of COVID-19 or have had a fever within the past 7 days. Children will be given a verbal health screening, as is required by Eagle County Health Ordinance.
- Children may not attend if they are in isolation or quarantine.
- Children exhibiting any symptoms of COVID-19 will be sent home immediately.
- Children will need to be dropped in front of the Club by a parent and picked up promptly at the end of lesson time.
- We will not allow parents on court at this time.

• Children will need to wear a mask through the check in front desk area on the way in and out of the club and on indoor tennis courts. They will not be required to wear a mask while outside on court. Pros are not required to wear masks while outside on court.

- Lessons will be held outdoors on Court 1 & 2. In case of rain, lessons will move inside to courts 7 & 8.
- Children will be asked not to handle balls, and will be asked to maintain social distancing to the best of their ability.
- Children need to bring their own water bottle and come with sunscreen on; neither will be provided by the club.
- Please have your children wash hands prior and following lesson times.
- If your child is unable to adhere to our policies and social distancing, they will be asked to leave the lesson.
- Please note our COVID-19 policies may change at any time without notice.

#### SUMMER 2021 JUNIOR TENNIS CLINICS TIMES & REGISTRATION FORM ON BACK

*Mighty Mites (4-6 year olds)* Emphasize hand-eye coordination, strokes, footwork, and most importantly FUN! This is an entry level 30 minute clinic, offered 1-5 days per week. Free racquet if you're a 1st timer in our program!

*Superstars (7-9 year olds)* Work towards developing dependable strokes, ball placement, and consistency. This is an entry level 60 minute clinic, offered 1-5 days per week.

Junior Aces (10+ year olds) Proceeding towards more advanced tactics, and the technique needed to execute those tactics. More advanced point play is introduced, but there is room for kids who are just beginning to play tennis. This is an intermediate 60 minute clinic, offered 1-5 days per week.

*High School Prep (12+ years old)* This class is designed for players who have limited tennis experience and want to get involved in a new sport or refine their skills for future groups. This is an intermediate level 60 minute clinic, offered 1-5 days per week.

*High School Advanced (14 + year olds)* Players who are generally more experienced with match play. Education, exercise, and entertainment (having fun) is still the key. A sense of team spirit and good sportsmanship is developed with this group. This is an intermediate to advanced 90 minute clinic, offered 1-5 days per week.
