Children's Tennis Policies:

Mighty Mites (4-6 year olds) Emphasize hand-eye coordination, strokes, footwork, and most importantly FUN! This is an entry level 30 minute clinic, offered 1-3 days per week. Free racquet if you're a 1st timer in our program!

Superstars (7-9 year olds) Work towards developing dependable strokes, ball placement, and consistency. This is an entry level 60 minute clinic, offered 1-3 days per week.

Junior Aces (10+ year olds) Proceeding towards more advanced tactics, and the technique needed to execute those tactics. More advanced point play is introduced, but there is room for kids who are just beginning to play tennis. This is an entry to intermediate 60 minute clinic, offered 1-3 days per week.

High School Prep (12+ years old) This class is designed for players who have limited or no tennis experience and want to get involved in a new sport or refine their skills for future groups. This is an entry level 60 minute clinic, offered 1-3 days per week.

High School Advanced (14 + year olds) Players who are generally more experienced with match play. Education, exercise, and entertainment (having fun) is still the key. A sense of team spirit and good sportsmanship is developed with this group. This is an intermediate 90 minute clinic, offered 1-5 days per week.
