Children's Tennis Policies:

## FALL 2024 SESSION 2 JUNIOR TENNIS CLINICS TIMES & REGISTRATION FORM ON BACK

*Mighty Mites (4-6 year olds)* Emphasize hand-eye coordination, strokes, footwork, and most importantly FUN! This is an entry level 30 minute clinic, offered 1-3 days per week. Free racquet if you're a 1st timer in our program!

*Superstars (7-9 year olds)* Work towards developing dependable strokes, ball placement, and consistency. This is an entry level 60 minute clinic, offered 1-3 days per week.

Junior Aces (10+ year olds) Proceeding towards more advanced tactics, and the technique needed to execute those tactics. More advanced point play is introduced. This is an intermediate 60 minute clinic, offered 1-3 days per week.

*High School Prep (12+ years old)* This class is designed for players who have some tennis experience and want to refine their skills for future groups. This is an intermediate level 60 minute clinic, offered 1-3 days per week.

*High School Advanced (14 + year olds)* Players who are generally more experienced with match play. Education, exercise, and having fun is still the key. A sense of team spirit and good sportsmanship is developed with this group. This is an intermediate to advanced level 90 minute clinic, offered 1-5 days per week.
